CYBERWIZE INDEPENDENT BUSINESS OWNER AGREEMENT & TERMS OF ENROLLMENT

1. As a CyberWize Independent Business Owner ("IBO"), I acknowledge I am an independent contractor and not an agent or employee of CyberWize. I understand I will not be treated as an employee for tax purposes. I acknowledge that I am not guaranteed any income, profit, or success, and that my signature below certifies that neither CyberWize nor my Sponsor has made any claim or guaranteed earnings or undocumented claims of anticipated earnings. Success or failure as an IBO is strictly dependent upon individual time and effort. I acknowledge my participation in network marketing and CyberWize (the "Activity") is entirely voluntary and involves the financial risk and costs associated with any personally owned and operated business. I expressly assume all risks and costs associated with the Activity.

2. I agree not to misrepresent the capabilities of any CyberWize product. I further agree not to create any materials describing CyberWize products, test results or product comparison literature unless authorized or previously approved in writing by CyberWize.

3. I agree that all my advertisements must be factual and non-misleading. Any advertisement promoting or representing employment, salaried positions, management positions, hourly wages, or guaranteed income is prohibited. I agree to comply with CyberWize's guidelines for advertising and will always disclose I am promoting a self-employment, or an "own-your-own-business" opportunity.

4. I acknowledge and agree that the CyberWize Compensation Plan is based upon the sale of CyberWize products and an IBO will not be successful merely by sponsoring other IBOs without regard to retail product sales. I agree that when using examples to illustrate how the compensation plan works, I will at all times make available the most current Income Disclosure available on www.CyberWize.com or as a document for order. I agree not to make any income claims or projections that state or promise any specific amount of compensation a prospective Independent Business Owner may earn, whether orally or in writing to other Distributors or prospective IBOs.

5. I acknowledge and agree that I may be terminated or disciplined for any violation of this IBO Agreement and Terms of Enrollment, Compensation Plan, Policies and Procedures, committing unfair or deceptive trade practices, or any other violation of law. I agree that I have read all provided written materials before selling any CyberWize product.

6. I acknowledge and agree that with every order of new product, I must certify that not less than 70% of the previously purchased product has been personally consumed or sold and must identify what portion of the product was sold and what portion was personally consumed. CyberWize will not repurchase products or issue refunds on products certified as having been personally consumed or sold. Falsely representing the amount of product sold or consumed in an attempt to circumvent this requirement may be grounds for termination.

7. I understand that the initial term of the IBO Agreement is one year from the date of its acceptance by CyberWize. IBO's must renew their IBO Agreement each year by paying an annual renewal fee of \$20 within 30 days of the anniversary date of their IBO Agreement. This is an automatic renewal and will remain in effect until the IBO notifies CyberWize in writing that they wish to terminate themselves as an IBO or until the IBO's business is terminated for misconduct. I acknowledge that this Agreement must be fully executed and complete hard copies on file with CyberWize before any commissions will be paid on my distributorship, and my distributorship may be terminated at the discretion of CyberWize if any of these pages has not been submitted fully executed within seven (7) business days of the date of Agreement.

8. I understand no product purchase other than an IBO Success Kit or an IBO Solutions Pak is necessary to become a CyberWize IBO. I understand I may terminate my AutoShip at any time. I further understand I am under no obligation to make any further financial investment to become a CyberWize IBO. I also understand any successful retail business will incur business expenses beyond the purchase of product. All IBO's are required to pay a non-commissionable \$14.95 (USD) monthly website hosting fee to keep their CyberOffice access active. The IBO Success Kit, IBO Solutions Pak, CyberOffice, and websites are sold to support the efforts of each new IBO with continued training and sales support.

9. I understand if no personal sales volume is generated for six consecutive months, this Agreement will automatically terminate, and all business volume and any future commissions and bonuses will be forfeited. I understand I may re-enroll in a new position after six months of not generating personal sales volume by submitting a new IBO Application and qualifying with at least 200BV in product orders. Once terminated, the IBO's business will not be available for sale or transfer.

10. I understand that should I wish to terminate my position as an IBO, I must notify CyberWize in writing. At such time, any salable product that has shipped within 365 days of the termination date may be returned to CyberWize for a refund equal to 90% of the original purchase price, less any commissions or bonuses paid, less the 70% sold or consumed (as certified in reorders). All returns must have a Return Merchandise Authorization (RMA) number. The RMA number can be obtained by calling CyberWize IBO Support at 941-371-1010. Perishable items, such as food or skin care products, will not be refunded after 30 days from date of purchase. In any state in which a specific buyback requirement has been enacted that may vary from the foregoing, CyberWize shall repurchase products and sales aids in accordance with any applicable statute.

11. I acknowledge and agree that in order to maintain a competitive marketing system and to comply with changes in applicable laws, CyberWize reserves the right to change prices, company policies, products, company literature, and/or the compensation plan without prior notice.

NOTICE OF RIGHT TO CANCEL

DATE of Transaction _____. You may cancel this transaction, without any penalty or obligation, within THREE BUSINESS DAYS from the above date.

If you cancel, any property traded in, any payments made by you under the contract or sale, and any negotiable instrument executed by you will be returned within TEN business days following receipt by the seller of your cancellation notice, and any security interest arising out of the transaction will be cancelled.

If you cancel, you must make available to the seller at your residence, in substantially as good a condition as when received, any goods delivered to you under this contract or sale, or you may, if you wish, comply with the instructions of the seller regarding the return shipment of the goods at the seller's expense and risk.

If you make the goods available to the seller and the seller does not pick them up within 20 days of the date of your Notice of Cancellation, you may retain or dispose of the goods without any further obligation. If you fail to make the goods available to the seller, or if you agree to return the goods to the seller and fail to do so, then you remain liable for performance of all obligations under the contract.
